# First Business - Update on Meet the Mavs night

# Second Business – Senior T-shirts (student)

## Sixth Business – Budget

Tracy was able to put together a budget, Michael will review in her absence.

Last year's PG lost money...\$2006.00. They did leave \$7800.00 for our PG. They started the year with \$12000.00 So we have to make some decisions regarding how we will approach this year.

Tracy put together three different budgets: (SEE ATTACHED)

- 1) YELLOW Working off of last year's numbers this shows a negative balance
- 2) BLUE raise more money, spend same amount has previous year
- 3) GREEN raise same amount of money, spend less

#### **Seventh Business** – Main Event

Tanya and Tiffany met with the main event coordinator.

Cost - \$55.00 per person up to 300

\$45.00 per person for 301 and above

This year, no outside food may be brought in, donated or purchased. This is because of liability laws and regulations in Austin.

The venue, including the menu, is being redone. We will not know until closer to event what all will be added and what the menu will be.

They did say we could bring in cake/cupcakes.

As for time to review the final bill, she will give us the bill a few hours before the final check needs to be given to Main Event. There was a gliche that hit all Main Events last year, so they are aware of what happened but it should not happen again.

As far a getting in and starting, they have us going from 12:30-6:00. But Tanya will check with them to see if they are open to us starting a little earlier, maybe 11:30-5:00. We will be allowed in an hour before the event starts to set up anything we need to set up.

Main Event will do a sweep of the facility for any hidden contraband. They also will have APD patrolling.

## **Eighth Business** – Covert Ford Drive

Mark Garcia spoke with Jason Whited regarding scheduling the test drive. They have not released dates yet and it will be close to the end of the year before they are released. We are on his call list. Mark will also follow up in December if he has not heard from Jason.

Mark has also contacted a couple other car makers to see if they do the same fundraiser but has not heard back from anyone.

# Ninth Business - Spirit Nights

Pamela McFall has several nights set up:

Bush's Chicken – September 22<sup>nd</sup> is date shooting for at the location by Round Rock HS...game that evening is at Dragon Stadium.

Newk's – 10% of all patrons – wanting to schedule this for October

Chipotle – set for November 10<sup>th</sup> at location near McNeil

Cover 2 – will do a spirit night with us but they have never done one so Pam will work with them to get the details worked out

Cajun Pizza – near McNeil, said they just need a weeks notice and they will do one for us. So since they are that easy, Pam will get everyone else scheduled and then plug Cajun in.

She is working with Whataburger but will probably wait until spring as they will not do Friday night because of football nights. They need 60 days notice.

She has not heard back form Chick-fil-a nor Schlotzskys.

### **Tenth Business** – Poinsettias

Diane is still waiting on the formal approval from school.

She has talked to the nursery. The price is going to be \$9 per plants, selling them for \$15.

Diane chose to have all red foils to keep things simple.

We have to commit to a certain number, NOW. Jan Markle handled last years that sold a lot more than 2016. 2016 sold 144 and 2017 sold 216. So Diane is going to get with them to see how they were able to sell that quantity. Maybe businesses? For now Diane is going to commit to 40 white /? Red.

Diane wants to start selling soon, September 15<sup>th</sup> and sell for three weeks with the possibility of adding one more week. Shooting for delivery the first week of December.

--The nursery is not going to be doing spring flower baskets this year. Diane will get with Rocky Epstein as she had some information about some other vendors.
